

GRAND LAKES MUNICIPAL UTILITY DISTRICT NO. 2
NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District (the "Board") will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being an official meeting place of the District.

The meeting will be held on *Monday, March 20, 2023, at 11:00 a.m.*

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

1. Public comments;
2. Review and approval of the minutes of the Board meeting held on February 20, 2023;
3. Discussion concerning matters related to past and future operations of the USACE Barker Reservoir;
4. Bookkeeper's Report, including financial and investment reports; authorize the payment of invoices presented;
5. Approval of Client Services Agreement with HR&P regarding direct deposit of director per diems and expense reimbursements and authorize acknowledgment of Texas Ethics Commission Form 1295 ("TEC Form 1295") in connection therewith;
6. Adoption of Resolution Authorizing Electronic Transfer of Funds for Director Per Diems and Expense Reports;
7. Authorize consultants to research unclaimed property and consider authorizing bookkeeper to prepare Unclaimed Property Report as of March 1, 2023;
8. Tax Assessor-Collector's Report, including status of delinquent taxes; authorize the payment of invoices presented, approval of tax refunds, and transfer of accounts to the uncollectible roll;
9. Review of Delinquent Tax Collection Attorneys' Report from Perdue, Brandon, Fielder, Collins & Mott, L.L.P.; authorize any action necessary and appropriate in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Discuss collection and use of Strategic Partnership Agreement revenues;

11. Operation and Maintenance Report, including:
 - A. Monthly report;
 - B. Appeals of District charges and other customer billing matters;
 - C. Repair and maintenance of District facilities, including consideration of any contracts for same and authorize acceptance of TEC Form 1295;
 - D. Refer accounts for collection;
 - E. Approve write-off of uncollectible accounts;
 - F. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - G. Cul-De-Sac Landscaping Improvement Project, including approval of cost summary for sod installation to be completed in early spring of 2023 and authorize acceptance of TEC Form 1295;
 - H. Consider revisions to the District's Drought Contingency Plan and discussion of refurbishing the District's conservation signage;
 - I. Evaluation of Pumping House;
 - J. Review proposal for conversion to electric reclaimed water lake feeds; and
 - K. Status of the Community Garden Irrigation Conversion Project;

12. Authorize annual submission to each electric utility that provides transmission and distribution service to the District and each retail electric provider for determination of District facilities that qualify for critical load status relative to compliance with Section 13.1396, Texas Water Code;



13. Authorize preparation of Annual Implementation Report regarding Water Conservation Plan and the filing of same with the North Fort Bend Water Authority (due May 1, 2023);

14. Engineer's Report, including:
 - A. Authorizing the design and/or advertisement for bids for construction of facilities within the District, and approving of related storm water plans;
 - B. Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of the District, and the execution of any documentation in connection therewith, including wastewater treatment plant site permit;
 - C. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and approval of any related storm water permits and authorize acceptance of TEC Form 1295;
 - D. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders and authorize acceptance of TEC Form 1295 related to same, including:
 - i. Replacement of Water Plant No. 2 wood fences ("Murr"); and
 - ii. Status of the conversion of the reclaimed water lines feeding the Community Garden to potable water lines; concurrence in the approval of any pay estimates and/or change orders related thereto;

- E. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes, including:
 - i. A 20-foot Water Line Easement from Grand Parkway Shopping Center, Ltd.;
 - F. Review and approval of amended Capital Improvement Plan;
- 15. Issuance of utility commitment request to Grand Parkway Shopping Center, Ltd. and authorize acceptance of TEC Form 1295 related to same;
- 16. Authorize preparation of:
 - A. Utility Development Agreement between the District and Grand Parkway Shopping Center, Ltd. and authorize acceptance of TEC Form 1295 related to same; and
 - B. Waiver Agreement between the District and Grand Parkway Shopping Center, Ltd.;
- 17. Review of annual survey of wage rate scales and consider adoption of Resolution Adopting Prevailing Wage Rate Scale for Construction Projects;
- 18. Consider approval of Fourth Amendment to Agreement between Owner and Engineer for Professional Services and authorize acceptance of TEC Form 1295;
- 19. Report from Murr Incorporated regarding landscaping renovations and improvements;
- 20. Discussion of Community Projects:

 - viii. Status of Pool Landscape Improvement Project ("GLAMCO"); and
